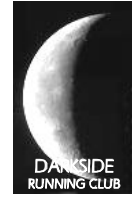




DARKSIDE RUNNING CLUB

Location: The race begins & ends at Luther Glass Park on Peachtree Parkway in Peachtree City, Georgia. *Park in the parking lot surrounding Kauffman Tire (near the Braelinn Village K-Mart at 400 Crosstown Road, Peachtree City, GA 30269)—about ¼ mile north of the intersection of Peachtree Parkway and Crosstown Road.*

Course Description: Six 5.18 mile loops for the 50K (*three loops for the 25K*) primarily on shaded and rolling asphalt golf cart paths. Two aid stations per loop as well as two unattended water fountains. Splits called after each loop. Both courses are certified. Food and drinks will be provided to all runners, support crews and volunteers. Portapotties available at the start/finish area.

Entry: \$35 entry fee for either race until 10/31; \$40 late fee until 11/13; \$50 race day. Awards: Awards for overall male/female in open and masters categories in both races. Age groups awards to top two in ten-year age groups (19/under, 20-29, 30-39, 40-49, 50-59, 60/over). Commemorative medals to all finishers in both events. All entrants will receive a unique gift symbolic of the event.

Results: All entrants will receive a commemorative on-line issue of *Tales from the Darkside*, featuring exclusive event coverage. Also, 50K results will appear in *Ultrarunning* magazine.

PLEASE NOTE! If you plan on completing the 50K (or the 25K, for that matter) in over 7 ½ hours, please take advantage of our 'early start' at 6:00 a.m., as we will be sending our volunteers home at 3:30 p.m. We will provide a lighted escort for one lap (so everyone will have to stick together!). After the first lap, you will be able to see and follow the course markings. ***Please keep in mind you will not be eligible for overall or age group awards!***
